Election of 2022 Officers

As our June bylaws amendment provides and in order to assure some continuity on the board (and avoid having a totally new board!), we will elect officers for 2-year terms - President, Treasurer, and Board Member At Large in odd numbered years, and Vice President and Secretary in even numbered years.

Sally Wright, VP, and Barbara Haugen, Secretary, are remaining on the board for just one more year. A new Vice President and Secretary will be elected in December 2022.

The following slate of 2022 officers was unanimously approved:

- President: Diane Wespiser (2 years)
- Vice President: Sally Wright (1 year)
- Treasurer: Ina Forman (2 years)
- Secretary: Barbara Haugen (1 year)
- Board Member At Large: Barbara Stroup (2 years)
 - Barbara is also a member of the Program Committee and will act as liaison between that committee and the board

Visitor's Fee Bylaws Amendment

Background:

- Section 2.2 of our Bylaws states: "Guests who attend single meetings will be asked to pay \$5."
- The board suspended that requirement when, due to Covid, we began meeting via Zoom because we had no way set up to collect that \$5 fee and had no idea how long we would need to continue meeting via Zoom.
- Instead, visitors have been offered two Zoom meetings "as our guests" meaning for free before we require full membership in order to receive the Zoom meeting link.

The proposed bylaws amendment:

Visitors may attend one meeting as our guests. For any subsequent meeting they wish to attend they will be asked to pay \$5 when the program is presented by a member of the guild, and \$10 when the program is by a paid presenter who is not a member of our guild.

Discussion of the proposed bylaw resulted in general consensus on the following points:

- Offer one "free" meeting to visitors even if we have a paid outside presenter at that meeting
- For subsequent visits require a \$5 fee paid prior to receiving the meeting link
- But charge \$10 if we have a paid outside presenter

Currently, when a "regular" member of our guild (not a professional quilting teacher) presents a meeting program, s/he is offered a \$50 honorarium. We are very fortunate to number among our members several award-winning and nationally known professional quilting teachers. The proposed bylaw does not cover the situation when one of our professional members presents a meeting program for which any other MQG chapter would pay her/him considerably more than \$50. The professional member would likely offer us a discount, but their fee would be greater than the usual \$50 honorarium.

We agreed to send the proposed bylaw amendment back to the board to come up with language that covers the professional member situation.

Thanks to her, we made potholders for each other and had the opportunity to have deep conversations with each other as we connected, and then shared some of what we learned with the bigger group. She worked hard with Lauren Price to bring the holiday game to fruition.

Barbara Farrell has kept our banking and accounting in order. She keeps the big picture of finance in mind, while taking care of all the little pieces that keep us legal.

I also want to thank the people who worked behind the scenes in programming, especially Sherry Morgan, Lauren Price and Betsy Wolfson.

We restarted a Community Quilts Committee, with Betty MacLeod, Suzi Day and Denise Leduc. Suzi and Denise have also been willing to donate their time to quilt any tops that people complete.

A small group met in person at Suzi and Denise's studio to work on the charity quilt designed by Diane Wespiser for QuiltCon 2022. We also viewed

the quilts on display at the Williamsburg Snack Bar.
